GELP, a limited partnership, was not subject to the diversification requirements, specific tax restrictions and investment limitations found in the Investment Company Act of 1940, or Subchapter M of the Internal Revenue Code. Had GELP been managed as a registered investment company pursuant to these restrictions, its results could have been different.
